Buddhashanti Rural Municipality, Budhabare, Jhapa has signed a contract with Alternative Energy Promotion Centre (AEPC) for the Design, Supply, Installation, Testing and Commissioning of Solar Street Light whereby 70 percent of total project cost under direct payment from AEPC and remaining 30 percent of eligible payment to be beard by the office. Under this condition, the office invites E-Bidding from eligible bidders for the aforementioned purpose. Eligible Bidders may obtain further information at the office of rural municipality. Telephone No: 023-555208/555044 Eligible Bidder's must submit the following document to buy tender document.

1. Qualification requirement details can be obtained from Bidding Document and a complete set of bidding document may be purchased from the office of rural municipal executive by eligible bidders on the submission of a written application, on or before 17:00 hrs. (25th Oct. 2019) along with the copy of company/firm registration, business registration certificate, VAT registration certificate, tax clearance of fiscal year 2075/76, a proof of its enlistment in AEPC standing list and upon payment of a non-refundable fee mentioned below.
2. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: 85CA499513524003 of Buddhashanti Rural Municipality Office, Budhabare, Jhapa in NIC ASIA Bank, Budhabare Jhapa and shall submit bank deposit voucher along with the bid.
3. Bids must be submitted online through e-procurement portal <http://www.bolpatra.gov.np/egp> only. It will be opened at 14:0 hrs. on the same date of last date of submission in the presence of bidder or their representatives. But this doesn't restrain in opening of the bid in the specified time.
4. Online bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting as mentioned below which shall be valid for minimum 30 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the e-GP system during bid submission
5. If the specified date for last date of submission and opening falls on a Government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last date for bid submission.
6. Any intimidation, collusion and car telling during bidding process shall be punishable by law.
7. All other remaining things of the project will be according to prevailing acts and regulations.
