The Buddhashanti Rural Municipality has allocated funds to cover eligible payment under the Contract for Supply of RCC Hume Pipe (NP3) with transportation and placing in specified site (IFB No: NCB/BRM/JHAPA/SUPPLY/HUMEPIPE/02-076/77). Bidding is open to all eligible Nepalese Bidders under National competitive bidding procedures specified in Public Procurement Act and Regulations.
2. Buddhashanti Rural Municipality invites electronic bids from eligible bidders for the procurement of Supply of RCC Hume Pipe (NP3) with transportation and placing in specified site of Buddhashanti Rural Municipality under National Competitive Bidding procedures.

4. Bidder should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, should submit their bid electronically, and should deposit the cost of non-refundable amount of NRs 3000 for bid in the following Rajaswa (revenue) account as specified below.

5. Pre-bid meeting will be not be held.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 27th October 2019. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 27th october 2019 at the office of Buddhashanti Rural Municipality Budhabare Jhapa Nepal. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of Nrs. 68000 (In Words: Sixty-eight thousand only) which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. All other issued shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
