- 5. Electronic bids must be submitted through PPMO's e-GP system **www.bolpatra.gov.np/egp** within12th hr of 31st day from date of publication.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13th hr on the same day of bid submission at the office of Buddhashanti Rural Municipality Budhabare, Jhapa, Nepal. Bid will be valid for a period of 90 days after date of bid opening and must be accompanied by submission of original voucher of bid security amounting to as mentioned below which shall be valid for 30 days beyond the validity period of the bid.Bidders can submit the bid security amount in the GA 3 DHARAUTI KHATA-BUDDHASHANTI GAUPALIKA held on NIC Asia Bank Ltd., Budhabare, A/C No.: 85CA499513524003 and submit by uploading the original voucher along with the Bid Document.
