1. ***Buddhashanti Rural Municipality has allocated funds*** from *GoN* towards the cost of ***Buddhashanti Rural Municipality Administrative Building Construction (Multiyear Project)*** and intends to apply part of the funds to cover eligible payments under the Contract ***for Bids No: 11-BRM/WORKS/079/80***. Bidding is open to all eligible as per Section V of bidding document.
2. ***Buddhashanti Rural Municipality*** invites sealed bids or electronic bids from eligible bidders for the construction of ***Buddhashanti Rural Municipality Administrative Building Construction with sanitary and electrification*** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: ***NRs. 59,300,000.00***
 - Minimum Work experience of similar size and nature: ***NRs. 47,400,000.00***
3. Under the ***Single Stage, Two Envelope Procedure***, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of ***[Name, location, mailing address, telephone and facsimile numbers and email address of the Employer]*** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder should submit their bid electronically should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before ***12:00 PM*** on ***2080-02-22 (2023-06-05 AD)***. Bids won't be received after this deadline.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***1:00 PM*** at ***2080-02-22 (2023-06-05 AD)*** at the office of ***Buddhashanti Rural Municipality***. Bids must be valid for a period of ***90 days*** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format in e-bid, amounting to a minimum of ***NRs. 19,70,000.00***, which shall be valid for 30 days beyond the validity period of the bid (***2080-06-15 (2023-10-02 AD)***)
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
